

# Process Safety Performance Indicators within Rhodia: a worldwide process



#### • 3 TYPES OF PERFORMANCE INDICATORS:

- N°1: Process Safety position requirements with 4 MACROTASKS (1 indicator)
  - Conduct PHAs as a guarantor (40% of FTE)
  - Get Safeguards audits for each site
  - Write Learning lesson letters from accidents (at least 2 per year)
  - Be part of MOCs as a risk analyst (40% of FTE)

► In order to be part of the Process Safety family (DRC corporate procedure): about 40 peoples

#### • 3 TYPES OF PERFORMANCE INDICATORS (cont'):

- N°2: RHODIA RED LINES (2 indicators)
  - Risk Analysis schedule: a 5 year-based review on P&IDs
  - Risk sheets level 1 or 2 "c" mitigation done with the support of experts (SIS/ dispersion modelling/ATEX/dust or vapour explosion/methods)
- N°3: FEED BACK (3 indicators)
  - Accident report: a monthly report system on C, H, M, L severity accidents
  - Controls on risk management : plant/production/maintenance
  - Audits on safeguards: operability of safeguards

#### • A GOVERNANCE TOOL :

- The Dashboard is used in all zones (66 plants):
  - Under the supervision of Industrial Directors for each GBUs
- Frequent Update :
  - Once/month
- A control loop:
  - Presentation during Industrial Directors Meetings : benchmarking
  - Dashboard communicated to more than 1400 peoples (10% of total employees)
