
All companies and organizations that deal with hazardous materials or processes are welcome to join EPSC and participate in our active sharing community.

Membership

Any company with an active interest in process safety can apply for membership. A wide selection of process industry sectors are represented including, oil and gas, pharmaceuticals, agrochemicals, steel, energy, storage and chemical production. EPSC has two membership levels:

Full members

Representatives participate in the Technical Meetings, where the Centre's work program is determined. Representatives can join in working groups, are entitled to vote on operational matters and may stand for election to sit on the Board. Full members pay an annual subscription based on their global turnover.

Associate members

Intended for non asset owners, receive the same information as Full members, including reports, learning sheets, and minutes and presentations from the Technical Meetings. Associates' representatives may participate in technical meetings and EPSC working groups on an invitation basis. All new memberships have to be approved by the board.
